Dear User!

We care about your privacy and we want you to feel comfortable while using our services. Because of that, we present most important information about the rules of processing your personal information and cookie files used by our service. This information was prepared with GDPR in mind, a global regulation of personal data processing.

Personal information and privacy




If you want to use our services, you will be asked for your personal information. Your data is processed by us for the purposes indicated below, relating to the functioning of the Website and the provision of services offered within it (“Services”).

The goal of processing:

Depending on what you decide, it can be:

- Performing the offered services
- Direct marketing of offered services, other than the newsletter
- Sending a newsletter

The basis for processing your data:

-  A contract for the provision of services or activities undertaken at your request, aimed at the contract’s conclusion (Art. 6, par. 1, point (b) of the GDPR).
-  Our legitimate interest in the processing of data to establish, assert, or defend any claims (Art. 6, par. 1, point (f) of the GDPR).
-  Our legally legitimate interest (Art. 6 par. 1, point (f) of the GDPR) in:
 - data processing for analytical and statistical purposes
 - surveys of customer satisfaction

Providing data:

- This is voluntary, but in some cases it may be necessary to conclude a contract.



The effect of not providing data:

Depending on the purpose for which the data is provided, not providing data may result in:

- the inability to use the services of the Website
- the inability to receive information about promotions or special offers offered on the Website

Processing period

We will only process your data for the period during which we have a legal basis for it, therefore, until:






-  the possibility of pursuing claims related to the contract concluded between the Website and the Parties ceases to exist
 -  your opposition to the processing of your personal data is accepted - if the basis for the processing of your data was the legitimate interest of the administrator, or if the data were processed for direct marketing purposes.
- depending on what is applicable in the given case and which is most recent.

Data safety

While processing your personal information, we use all possible organization and technical means allowed by the law.

Your rights

You have the right to request access to your personal data to:

-  access your personal data
-  change
-  delete
-  restrict the processing of, and
-  transfer the data to another administrator

And you have the right to, at any time:

- object to the processing of your data:
 - for reasons related to your particular situation in the processing of personal data concerning you, based on Art. 6, Par. 1, point (f) of the GDPR (i.e. on legally justified interests carried out by the administrator),
 - if personal data is processed for direct marketing purposes

If you think your personal data is processed illegally, you can file a complaint to a supervisory authority.

Cookies

Our Website, like most websites, uses cookies. These files:

- are saved in the memory of your device (computer, telephone, etc.)
- enable you to use all the functions of the Website
